Political, legal and financial policy decisions in Sweden and globally promote SRHR and sustainable development for all people nothwithstanding, their power and resources.

Norms and attitudes in Sweden and globally afford people greater opportunities to enjoy and make decisions about their bodies and sexuality. People in Sweden and globally, nothwithstanding their power and resources, have:

- improved access to qualitative and equal sexual and reproductive care.
- more opportunities to organize and influence sexual and reproductive health and rights.
- increased knowledge about bodies and sexuality.
- ▶ Norms about the body, sexuality and relationships create enhanced and equal conditions for desire and pleasure, and are not limited by any power structure.
- ▶ SRHR actors and other social justice movements jointly mobilise for sustainable development from an SRHR perspective.
- ▶ A strong and independent civil society supports SRHR and expands democratic space.
- ▶ More people have more opportunities to live, form relationships, and start a family in the manner they wish without being hindered by discriminatory legislation or restrictive norms.
- ▶ Improved access to quality and equal sexual and reproductive healthcare for all people, notwithstanding power and resources.
- ▶ More children and young people, notwithstanding power and resources, have equal access to sexuality education and knowledge about sexuality, the body, and relationships.
- ▶ More people, notwithstanding power and resources, have access to legal and safe abortion, and abortion stigma has decreased.
- ▶ More people, notwithstanding power and resources, have access to and knowledge of contraception.
- ▶ People's sexual and reproductive health and rights are characterised by equality and consent and are not limited by gender-based violence, harmful practices, or honour-related violence and oppression.
